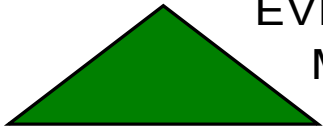

2025 WATER HAULING REGULATIONS

GENERAL

The season for hauling will be year-round. Hauling may be done 24 hours per day if HAULER has an access code and pin to the system.

There will be a \$500 annual (non-refundable) permit fee. One access code & card will be assigned per permit. If additional codes are issued, the administrative office must know the license plate number of the truck the code will be assigned to. This is for tracking purposes. All accounts will be billed on a monthly basis. Cost per thousand gallons is \$50.00 (\$.05 per gallon), or fraction thereof. The equipment will do all the logging of water hauled, according to the code used. If an account goes 30 days delinquent the code issued to the account will be deactivated and must be paid in full for code to be re-activated. Before your code will be activated for the 2025 year your account must be current with no overdue balance.

Damages to District property will be billed at cost plus 28% (18% on materials and 10% on labor) and could also include forfeiture of right to use water hauling station.

Water sales from the Bulk Station may be stopped or restricted due to environmental (drought) or other reasons deemed necessary by the Evergreen Metropolitan District.

The inoperability of the Bulk Station during off business hours (between 4:30 p.m. - 8:00 a.m. weekdays) or on weekends will not be construed as an emergency. The district will investigate and/or service problems with the station on the next business day.

TRUCKS AND TANKS

As of 2024 truck & air gap system inspections will no longer be required.

All HAULERS MUST SUPPLY THEIR OWN HOSE. Hose must be capable of hooking up to a 2-1/2" fire hydrant thread. Hose must have 2-1/2" female thread. All HAULERS must fill at the top using an air gap. DO NOT BOTTOM FILL INTO TANK.

Description of material in non-potable tank must be put on Permit, with specific antidote or manufacturer's name and telephone number. NO CHEMICAL MIXING SHALL BE DONE AT THE FILL STATION.

PENALTIES FOR VIOLATIONS

Any water HAULER violating the air gap filling regulation will lose all privileges of hauling from the Evergreen Metropolitan District water system. Hauling without a permit or from unauthorized areas, such as fire hydrants, will result in a \$150.00 fine and revocation of the HAULER'S permit. All costs incurred by such acts shall be billed to the HAULER, according to the fee schedule, including all legal costs, state fines, lawsuits and damages.

Violation of any of the regulations will result in the immediate revocation of the water hauling permit. A hearing may be held, if requested by the HAULER in writing. Submit request for hearing to:
